Sturdy Oil shall have all remedies as provided in the uniform Commercial Code upon default including the right to take immediate possession of customer's inventory. The undersigned hereby states that he is authorized to bind the customers to the terms hereof.

INDIVIDUAL PERSONAL GUARANTY

(Hereinafter "Guaranty")

Guarantor hereby waives notice of default, nonpayment, and notice thereof, and consents to may modification or renewal of the credit agreement hereby guaranteed. This Guaranty is binding on Guarantor and Guarantor's heirs, personal representatives, successors and assigns. If any provision of this Guaranty or the application thereof to any person or circumstance shall, for any reason and to any extent, be invalid or unenforceable, neither the remainder of this Guaranty nor the application of such provision to any other person or circumstances shall be affected thereby, but rather the same shall be enforced to the greatest extent permitted by law.
